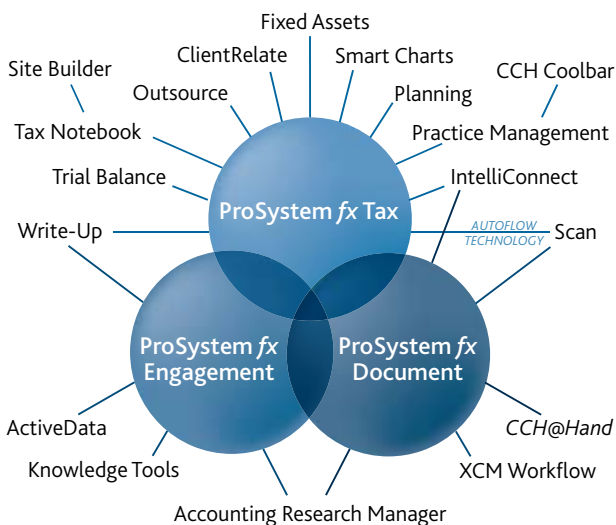

DATA STORAGE AND PROTECTION

Using the best technology in the market today, Global fx provides secure data storage, back-up and archiving, as well as the latest virus protection.

With Global fx, your return information is safe in the event of a computer failure or other unforeseen disasters, such as fires, floods, and other destructive weather conditions.

No matter what happens at your office, your Global fx returns are safe with us, thanks to:

- **Secure Server Hosting** – Global fx programs and data reside on powerful, centralized servers protected by data encryption routines, firewalls, and other robust security measures that prevent unauthorized access. Your data is backed up daily and is also replicated to a secure, remote location several times per day. Servers are clustered using the Microsoft® cluster service and an EMC SAN is used to provide reliable database storage. If you also license a desktop tax application, you can always back up client data to your local systems as well – the choice is yours.
- **Unmatched Security Features** – Making certain that client data is secure from unauthorized access is of utmost importance. At CCH, we are committed to keeping your client information absolutely private and recognize the importance you place on the privacy and confidentiality of client information.
- **Encryption** – Global fx requires 128-bit encryption for all communication between the client workstation and our Global fx servers. In addition to 128-bit encryption, Global fx uses SSL (Secure Socket Layer) to ensure data is secure when transferred over the Internet.
- **Firewalls** – Global fx uses firewalls to prevent unauthorized access to the Global fx network. For offices that have firewalls or routers, specific ports opened for outbound requests and inbound replies are the only configuration needed.
- **Anti-Virus Protection** – When you use Global fx, you're using the latest anti-virus software. All your files are scanned using the latest virus definitions, straight from the anti-virus software vendor, so that virus threats are monitored and your data is kept safe from virus attacks.
- **Password Authentication** – Every user who will access Global fx will require a unique username and password.
- **Unauthorized Access to Client Data** – Your client data is protected by encryption, firewalls, and password authentication.
