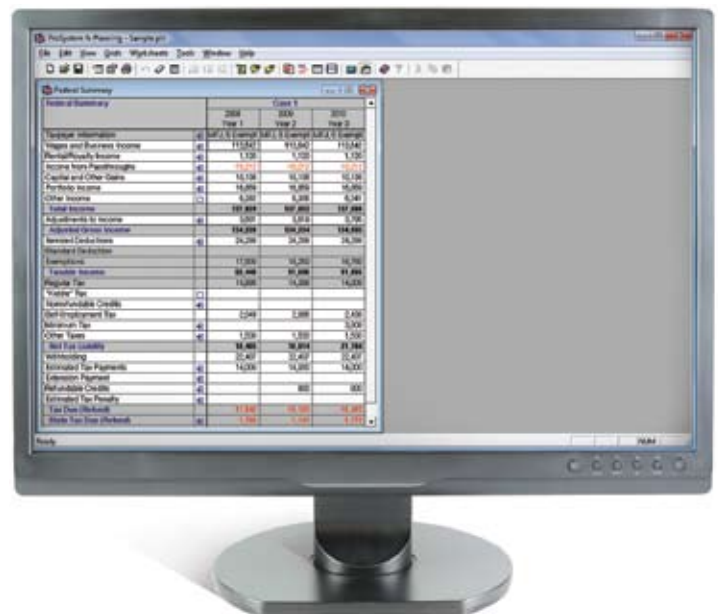

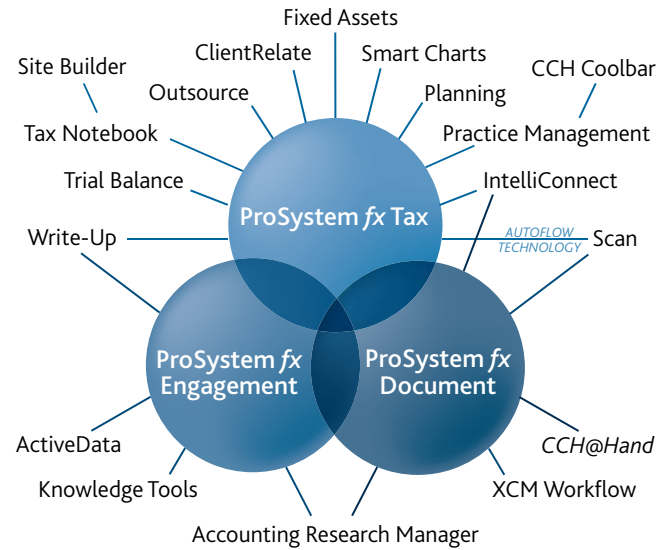
- Complete federal tax calculations including:
