How Do I



✓ Browse Through Publications and Topics

- Click a tab.
- Click a publication or topic to see a menu of subtopics.
- Continue clicking links until you find a document or an item to search.

✓ Search Using Keywords

- On a library tab, click the checkbox next to the item(s) you want to search.
- Type your search terms in the box on the navigation bar. (For example, *Roth IRA*)
- Click **Search**.

Using Search Tools

With Search Tools, you can change your search method, customize your results and target specific document types. Select items to search and type your search terms. Then click **Search Tools**, select your options and click **Search**.

✓ Search Using a Citation

- On a library tab, click the checkbox next to the item you want to search. (For example, select "Cases" if you are looking for a case.)
- Click **Find by Citation**.
- In the box next to the appropriate citation format, type the citation. (For example, *IRC Sec. 401(k)*)
- Click **Search** next to the box.
